

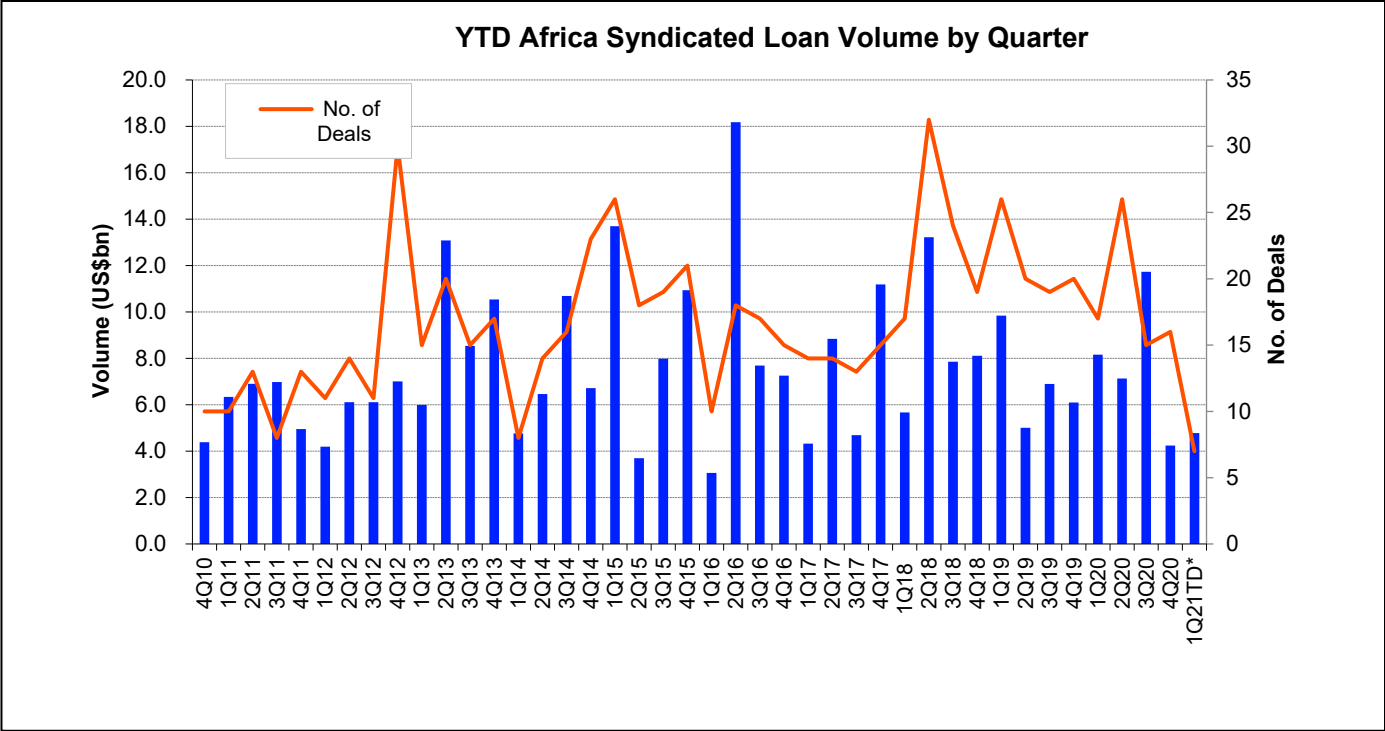

Africa Syndicated Loan Volume by Quarter

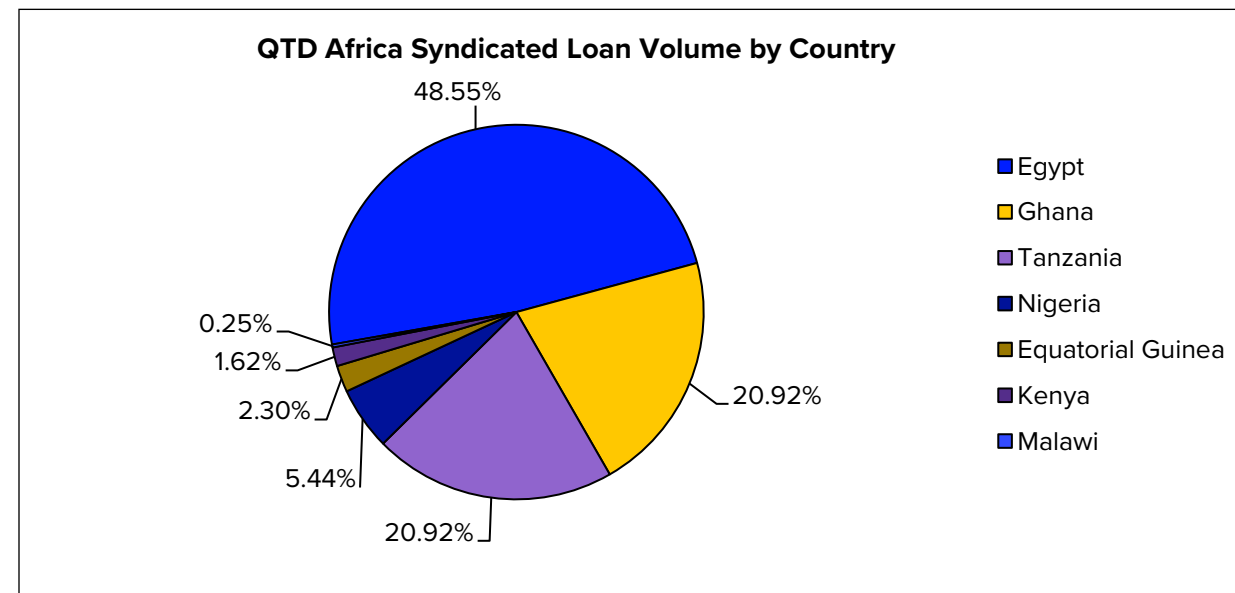
Quater to date, there has been US\$4.78 billion issued across 7 deals in Africa. This amount includes five deals which are in-process and worth \$4.44 billion together. The two completed deals totaled US\$337.5 million.

Quarter to date, 'ANOH Gas Processing Plant' from Nigeria has the largest completed deal at US\$260 million. The largest deal in-process amounts to US\$2.32 billion for the 'Egyptian Monorail' transaction. Kenya had the second largest completed deal worth US\$77.5 million for Gulf Power Ltd. The Republic of Ghana and Tanzania Ministry of Finance, each have a US\$1 billion deal in process.
